SECOND AMENDMENT TO THE BYLAWS OF

THE ORCHARD VILLAS CONDOMININIUM UNIT OWNERS ASSOCIATION, INC.

THIS AMENDMENT TO THE DECLARATION AND BYLAWS OF THE ORCHARD VILLAS CONDOMINIUM UNIT OWNERS ASSOCIATION, INC., made this 19 of July. 2021, by the undersigned Directors on behalf of the Orchard Villas Condominium Unit Owners Association, Inc., a North Carolina non-profit corporation, hereinafter referred to as the "Association."

WHEREAS, the Declarant, Apex OV, LLC, a Virginia corporation, hereinafter referred to as the "Declarant", executed and caused to be recorded in the office of the Register of Decds of Wake County, North Carolina, in Book 13231, Page 01555 through page 01626, the Declaration of the Orchard Villas, a Condominium and attached thereto and therein incorporated by reference were the Bylaws of The Orchard Villas Condominium Unit Owners Association. Inc.; and

WHEREAS, the Declarant executed and caused to be recorded in the office of the Register of Deeds of Wake County, North Carolina, in Book 13753, Page 00995 through page 00998, the first Amendment to the Declaration and Bylaws of The Orchard Villas Condominium Unit Owners Association, Inc.; and

WHEREAS, contained in said Bylaws are certain provisions relating to the audit of the Association's account and financial records found specifically in paragraph 7.3; and

WHEREAS, the Association, acting within the provisions of Article VIII, does hereby wish to amend the Bylaws; and

WHEREAS, Members of The Orchard Villas Condominium Unit Owners Association, Inc. have voted to amend a provision of the Bylaws, described below.

NOW, THEREFORE, IT IS RESOLVED AND AGREED, as indicated by the signatures appended hereto of not less than two-thirds (67%) of the members present at the vote or present via proxy:

- 1. That Paragraph 7.3 entitled "Audits" contained in Article VII of the Bylaws is hereby amended as follows:
- 7.3 Audits. All books of account and financial records shall be kept in accordance with good and acceptable accounting practices. The Board shall have a review or audit of the books of account and financial records of the Association made by an independent certified public accountant following the close of each fiscal year and the report of such accountant shall be received by the Board and made available for inspection by all Unit Owners and all mortgage holders within the following year.
 - 2. That the Bylaws shall otherwise remain unchanged by this Second Amendment.
 - 3. That this Second Amendment to the Bylaws is effective upon the signature of the undersigned Directors, following a vote of approval of at least two-thirds of the members present at the regular or special meeting to consider the amendment of the Bylaws.
