DECLARATION

WAKE COUNTY

THIS DECLARATION, made this the 31st day of December, 1997, by CEDAR CREEK PARTNERSHIP, a NC general partnership, hereinafter referred to as "Owner";

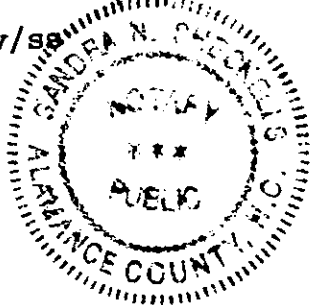
