NOW, THEREFORE, the undersigned does hereby declare that the Declaration of Covenants, Conditions and Restrictions for the Crescent Ridge Subdivision shall be amended as follows:

- 1. To amend Article 8.5, of the Declaration by deleting that section in its entirety and inserting in lieu thereof the following:
- "8.5. Animals. Except as set forth herein, no animals, livestock, or poultry of any kind shall be raised, bred, or kept on the Lots, except that a reasonable number of domesticated, household pets and up to five (5) female chickens may be kept, provided they are (a) not maintained for commercial purposes, (b) reasonably restrained while outside the residence, and (c) not permitted access to outside shelter which is (i) not approved by the Board of Directors, or the Architectural Committee, or (ii) visible from the street. Absolutely no roosters shall be allowed on a Lot."
- 2. This amendment shall be effective upon recordation in the Office of the Wake County Registry.
- 3. Except as amended hereinabove, the remaining portions of the Declaration as originally recorded are hereby restated and reacknowledged.

WHEREFORE, the President and Secretary of the Association have hereunto affixed the corporate certification for the purpose of enacting the foregoing amendment.
