THIS DECLARATION is made as of the 23 day of March, 2005, by WESTLAKE TOWNHOME PARTNERS, LLC, a North Carolina limited liability company ("Declarant").

WITNESSETH:

WHEREAS, Declarant is the owner of Lots 3 through 19, 25, 26, and 55, inclusive, and rights of way of Mauldin Circle, Steel Canyon Way, and Ormand Way, Crescent Ridge Subdivision (the "Subdivision"), Phase 2, containing approximately 31.015 acres in the aggregate, as shown on plat recorded in Book of Maps 2004, Page 2340, Wake County Registry ("Phase 2"); and

WHEREAS, Declarant wishes to subject Phase 2 to that certain Declaration of Covenants, Restrictions and Easements recorded in Book 9319 Page 672, Wake County Registry (the "Protective Covenants"); and

WHEREAS, pursuant to Section 3.2 of the Protective Covenants, Declarant may, within ten (10) years after the date on which the Association is incorporated (February 11, 2002), annex additional land located adjacent to or across a public or private street from the Property (as defined in the Protective Covenants), without the consent of the Members.

NOW, THEREFORE, Declarant hereby declares that Phase 2 is and shall be annexed to and held, transferred, occupied, used, sold and conveyed subject to all of the terms, requirements and conditions of the Protective Covenants, the provisions of which are incorporated herein by this reference.

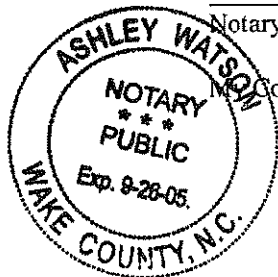

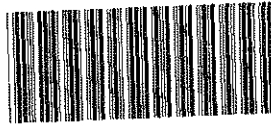
