SUPPLEMENTARY DECLARATION OF ANNEXATION

THIS SUPPLEMENTARY DECLARATION OF ANNEXATION is made this 20 day of January, 2021, by Highland Subdivision, Inc. and by not less than two-thirds (2/3) of the Members of the Dayton Woods Phases Two and Three Homeowners Association, Inc. ("Association").

WITNESSETH:

WHEREAS, Highland Subdivision, Inc., a North Carolina corporation, caused to be recorded a document entitled "Protective Covenants of Dayton Woods Subdivision Phases Two and Three" in Book 12255, Page 187 of the Wake County Registry, which was thereafter amended in Book 12630, Page 1902 of the Wake County Registry (collectively, the "Declaration"); and

WHEREAS, Highland Subdivision, Inc. is the owner of that real property referred to as the "Property" herein, and which is more fully described on Exhibit A attached hereto and incorporated by reference; and

WHEREAS, Highland Subdivision, Inc. desires that the Property be annexed and made subject to the Declaration, which shall be for the benefit of the Property and for each and every owner thereof, and shall inure to the benefit of and pass and run with the Property, and each and every lot or parcel or further subdivision thereof, and shall apply to and bind the successors in title, successors in interest and any owner thereof; and

Submitted electronically by "Jordan Price Wall Gray Jones & Carlton" in compliance with North Carolina statutes governing recordable documents and the terms of the submitter agreement with the Wake County Register of Deeds.

WHEREAS, Article VII, Section 5 of the Declaration provides that additional residential property and open space may be annexed with the consent of two-thirds (2/3) of each class of members, and there is currently only once class of membership in the Association; and

WHEREAS, at least two-thirds (2/3) of the members of the Association have approved annexation of the Property as evidenced by the certification attached hereto;

NOW, THEREFORE, the undersigned hereby declare that the Property is and shall be held, sold, transferred, conveyed, used, occupied, and mortgaged or otherwise encumbered subject to the Declaration, as it may be amended and supplemented, and Highland Subdivision, Inc. and each and every successor in interest, successor in title, or owner of any lot or parcel or other subdivision of the Property shall be a member of the Association, and shall be entitled to all of the rights, privileges, obligations, duties, and benefits conferred upon a member of the Association as set forth in the Declaration. The Declaration and the easements, covenants, restrictions, assessments, and conditions described therein shall run with the land and shall be binding on all parties having or acquiring any right, title or interest in the Property or any part thereof and shall inure to the benefit of each owner thereof.
